The possibility of creating an “off the leash” dog park at Angeles Gate Park, which is now the “unofficial” community dog park. Is this a fairly inexpensive possibility, as the area is already enclosed by fencing? What legalities and logistics are involved?

The Pacific Overview or Sunset Park, has just been so beautifully landscaped with drought tolerant plantings that it is unfortunate that at certain times of the day tourists and locals are intimidated to enjoy the scenic view because the skate boarders have taking over the area. There are several inexpensive remedies that discourage boarding, and perhaps it's time to begin exploring the possibility of installing a skate board park in our area, maybe somewhere in the Angel Gate Recreation Center.
